## Introduction to the Client Portal for SurroundLab AR

The Client Portal for SurroundLab AR is the ideal way to boost client satisfaction and improve your workflow. Empower your clients with the ability to manage their invoices and missing information requests, anytime and anywhere.

### ***How can the Client Portal improve efficiency and reduce costs for your laboratory?***

Fully integrated with SurroundLab AR, the Client Portal makes perfect sense for your bottom line by:

- Streamlining your workflow and reducing manual processing of payments and missing information.
- Boosting efficiency and saving money with less printing and mailing of paper statements. Reduces the faxed missing information requests to your clients.

### ***Convenient and easy for Clients:***

Verified payments are immediately applied to a batch within SurroundLab AR, which can be quickly reviewed and posted. Management Reports allow for close monitoring of web based payment activity. Updated missing information is instantly sent to SurroundLab AR, resulting in a shorter request to completion cycle.

## Configuration Settings in SurroundLab AR

The Client Portal application utilizes File Definition, as well as the Order Entry and Transfer Queue work queue data, from SurroundLab AR. No patient or client data is stored by the client portal. Updates made in SurroundLab AR are immediately available on the web, and vice versa. If desired, optional configurations to workflow can require 1 - manual review of edits before they are sent to the portal and/or 2 - data coming from the portal before it is filed in SurroundLab AR Order Entry.

This Configuration Checklist is an overview of the SurroundLab AR files used by the Client Portal.

- ✓ Update your Client Payer(s) to use Portal Edits in Client Definition
- ✓ Configure Email Notifications in place of Client Statements using Payer and Client Definition
- ✓ Categorize your Edits and Customize your workflow using the Portal Edit Definition

### *SurroundLab AR Menus Associated with the Client Portal*

- ✓ *Portal Edits – These menus are used to review edit information being sent to and received from the Client Portal, when configured.*
- ✓ *Portal Notice – This menu is used to send notifications to Portal Users assigned to an Edit Category when new edits are ready to work on the Client Portal.*
- ✓ *Submissions – Like the Client Statement process, use the Submissions menu to send email notifications when a new statement is available online.*
- ✓ *Batch Edit Report/Batch Edit – Use this menu to review and apply payments.*
- ✓ *Web Ap Reporting – This management tool allows you to review summary or detailed information sent from the Client Portal to SurroundLab AR.*

## Replacing Client Statements with Email Notifications

Configuring your SurroundLab AR application to replace Client Statements with an Email Notification can be completed with a few easy steps. Email notifications save both time and money associated with printing and mailing Client Statements.

- ✓ Define a new Output Schedule Number for the form CLI STMT EMAIL in Payer Definition for the Client Payer ID(s). (The Client Payer ID is usually, C, CLI, CLIENT, etc.)
- ✓ Assign this Output Schedule Number as the Override Output Schedule in Client Definition
- ✓ Confirm an Email Address is present in Client Definition and, if not, obtain and enter one.

### Client Payer Output Schedule Step in Payer Definition

*Utilities → File Maintenance → Payer Options → Payer Definition (2,1,19,1)*

Clients may prefer to turn off paper statements altogether and receive notifications via the portal when a new statement (invoice) is available online. Since the statements are queued using the Payer Output Schedule in SurroundLab AR, you will need to create an Output Schedule Number for the email notifications and assign it to any Client IDs who prefer to receive notifications by email.

You must first define a new Output Schedule Number (example shows 2).

Complete the Delay Step #1 field as desired.

Complete the Form Name with the CLI STMT EMAIL and Sort By field.

Use the end of screen **[Save]** button before exiting this screen.

## Client Definition Settings

*Utilities → File Maintenance → Clients → Client Definition (2,1,1,1)*

### Assign the Override Output Schedule

To override the current statement Output Schedule for applicable Client IDs, use the Client Definition **Override Output Schedules** section in Client Definition. Select the **Output Schedule Number** that you defined for the **CLI STMT EMAIL** form. Instead of queueing to the usual statement form, these clients will now queue to the CLI STMT EMAIL form.

Like the Client Statement form, you must process this form through Process Submission 1,3,1,1 in order for the Client to be notified of a new invoice is available for review. To automate the processing of the form, use the Schedule Submission menu option at 1,3,1,2.

### Enter the Email Address for the Client ID

The Primary email address for the **New Invoice Email Notification** will need to be added to the applicable Client IDs. If there is a Master Client/Sub Client relationship defined and one bill is generated for the Master Client Level, only the Master Client needs to have an email address defined. Located on the Client Billing Address section of Client Definition is the new **Email** field.

## Select Portal Edits to Override the Missing Information Method

Use the Missing Information Letter Setup section of Client Definition to update the **Portal Edits of MI Letters** field to **P** for Portal Edits. If this field is not completed, SurroundLab AR will default to the MI Letter Transmission Method, found at the top of the same screen. It is not necessary to remove any of the previously defined settings for Missing Information. The Preferred MI Letter Transmission Method and the other Missing Information Letter Setup fields located above the Portal Edits or MI Letters field apply **ONLY** to MI Letters.

**Entering a P in the Portal Edits or MI Letters field overrides the Preferred MI Letter Transmission Method defined above so no MI Letters will be generated.**

## Processing the CLI STMT EMAIL form using Submissions

*Billing System → Submissions & Remittance → Submissions → Process Submissions (1,3,1,1)*

When a Client Invoice is closed, the invoice will be queued to the form CLI STMT EMAIL for processing. Like other SurroundLab AR forms, this form must be processed in order for the **Email Notifications** to be sent to the Client email addresses. This form does not produce a file output or report; enter **Screen** in the **Output Device** field and select the **Form Name** of **CLI STMT EMAIL**. Choose **[Print]** to process the form and send out the email notifications. The Billed Date will appear in the Invoice Manager Header and the Invoice Notes section. This form may be scheduled to process automatically using the Schedule Submissions menu option at 1,3,1,2.

## Defining Edit Categories for Client Portal User Assignment

### Edit Category Definition

*Utilities → Configuration Maintenance → System Codes → Edit Category Definition (2,2,8,8)*

You will use two screens to establish categories for SurroundLab AR Order Entry Edits. Edit categories can be assigned to a portal user. Only those categories assigned to the user will be viewable to the user on the web portal. If needed, a user can have access to all edit categories. An email will be sent when new edits in the assigned category are available to work on the Client Portal. Edits can be filtered by category on the Client Portal.

**Missing Info Edits visible to User:**

- Patient Demographics
- Diagnosis Related Edits
- Insurance Information
- Medicare A or B Eligibility
- Physician Information NPI
- Responsible Party Information

First, the **Edit Category Definition** screen is used to create categories for the edits. Categories are used to group similar Order Entry Edits together. For example, you may want to group edits for missing information related to Patient Date of Birth, Sex, Address, etc. as demographic edits. The provider's office might have different team members working diagnosis related edits than demographic edits.

Complete these required fields and select **[Save]** from the end of screen buttons.

**Edit Category ID:** Enter a new Edit Category ID, an existing Edit Category ID, or “/L” for a list.

**Description:** Enter a description, up to 40 characters.

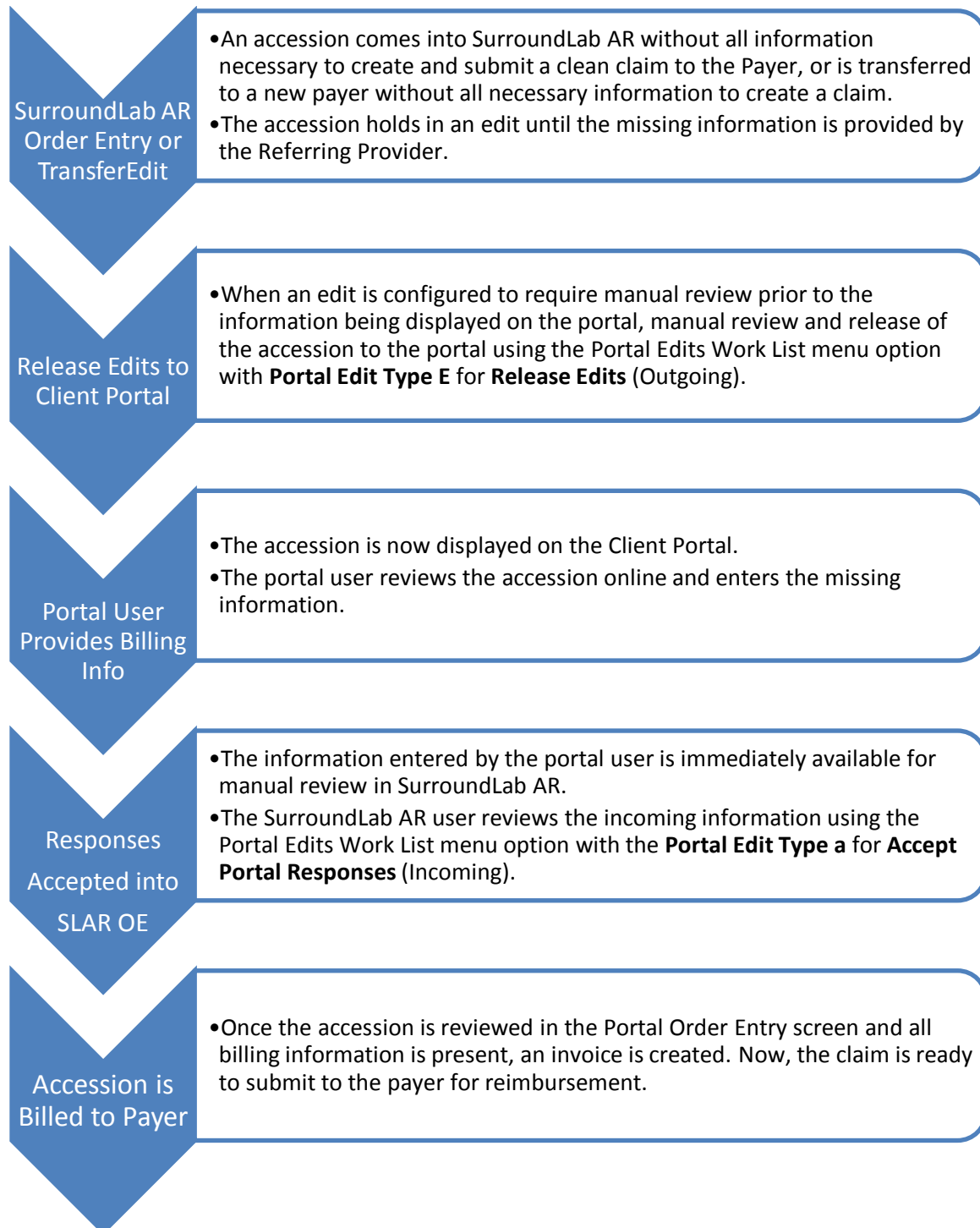

The second screen you need to complete is the **Portal Edit Definition**. In this screen, you will define categories and design a workflow for your edits.

## Establishing a Workflow for the Client Portal Edits

SurroundLab AR Order Entry Edits are displayed on the Client Portal in real-time. However, you may choose to insert controls for specific Client IDs and Edits that will force accessions to be manually reviewed. Below is an outline of the Edit Workflow when outgoing and incoming controls are defined. Use the **Portal Edit Definition** menu option to insert these controls by Client ID and specific Edit.

### Portal Edits Workflow with SurroundLab AR User Controls



## Portal Edit Definition

*Utilities → Configuration Maintenance → System Codes → Portal Edit Definition (2,2,8,9)*

The **Portal Edit Definition** screen displays a line for each edit defined with an **External Edit Type** in Company Definition. See the Set Edit Type for Order Entry Demographics panel of **Company Definition** (2,2,4,1) to change an Edit Type from External to Internal if an edit can be resolved in-house and should not be sent to a provider's office for resolution.

By Client, you will determine the category and workflow for each of the edits. This screen offers a copy feature to lessen the manual entry required. If a new edit is created through a SurroundLab AR build or as a custom edit, the Portal Definition screen will require an update for the new fields for each client.

**Note:** Remember to set these fields as part of your process when you create a new Client ID.

Complete the fields below and select **[Save]** from the end of screen buttons.

**Client ID:** Enter a valid Client ID, \* for All, or /L for a list. The (\*) All option is the default definition for all Clients not specified in the Portal Edit Definition.

**Copy From Client ID:** You may copy a Portal Edit Definition from another Client ID. Enter a Client ID or /L for list. A previously defined set of Edits for a client may be copied to a new client if desired.

**Edit Category:** Enter the Edit Category ID or /L for a list. This refers to the group of edits you previously defined in Edit Category Definition, i.e. DEMO, RESP, DIAG, MEDNEC, INS, etc.

**Review Outgoing Edit?** Enter YES if the portal edit needs to be internally reviewed before the edit is sent to the Client Portal. Otherwise, enter NO. *You have the option to review accessions with edits prior to their release to the Client Portal.*

**Review Incoming Edit?** Enter YES if the information that was entered in the portal for the edit can be automatically filed in SurroundLab AR. Otherwise, enter NO. *You have the option to review responses provided by the Client from the Client Portal before they are filed in SurroundLab AR.*

## Managing Data Exchange: SurroundLab AR ↔ Client Portal

The Portal Edit Work List is designed for a SurroundLab AR user to manage the flow of data to and from the Client Portal using the workflow you defined in the Portal Edit Definition (2,2,8,9) to determine which external edits require incoming and outgoing review.

**The Portal Work List should be worked daily, at minimum, to effectively manage the timely transfer of data to and from the Client Portal.**

There are two **Portal Edit Types**:

### E Release Edits to Portal (Outgoing) or SurroundLab AR → Client Portal

**Purpose:** To review Accession Order Entry or Transfer Queue edit details before they are released to the web portal. If the external edit is defined with **NO** in the **Review Outgoing Edit** field then it will not appear on a list when you run the **Release Edits to Portal** option in the Portal Edits Work List. These edits will be automatically released to the web portal application.

### A Accept Portal Responses into OE (Incoming) or SurroundLab AR ← Client Portal

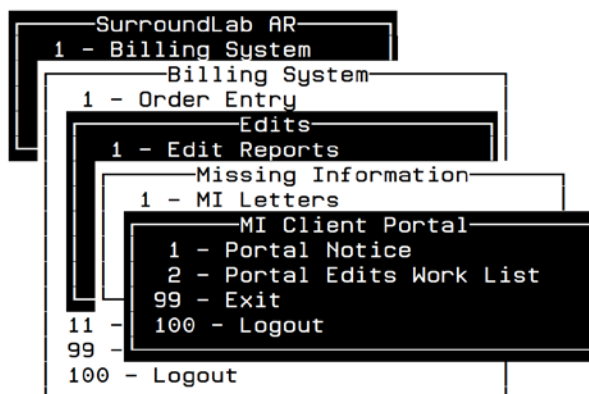
**Purpose:** To review the data sent to SurroundLab AR from the web portal prior to being filed in SurroundLab AR. If the external edit is defined as **NO** for **Review Incoming Edit**, it will not appear on a list when you run the **Accept Portal Responses into OE** option in the Portal Edits Work List. The data entered online will be automatically filed in SurroundLab AR to resolve the Order Entry or Transfer edit. If all edits have been resolved, the accession will automatically create an invoice for billing.

**Exception:** these will automatically process in SurroundLab AR unless an edit and/or Portal Notes on the same accession requires review and causes the accession to hit the Accept Portal Responses into OE (Incoming) or SurroundLab AR list.

### Portal Edits Work List

*Billing System → Edits → Missing Information → MI Client Portal → Portal Edits Work List (1,2,2,2,2)*

The **Portal Edits** are reviewed in a work list format using the Portal Edits Work List menu option. If you configured the external edits to require a review, you will need to use one or both of the following Portal Edit Types in the **Portal Edits Work List**. If SurroundLab AR has not been configured to require review then this option is not necessary and the edit information will flow freely to and from the Client Portal. *Refer back to the workflow when using the Portal Edits menu.*



### Portal Edits Work List Selection Screen

Complete the following fields to build your Portal Edits Work List.

**Portal Edit Type:** Enter E-Release Edits to Portal (Outgoing) or A-Accept Portal Responses in OE (Incoming). The Release Edits to Portal (Outgoing) option will allow you to review the Edit before it is sent to the Web Portal. The Accept Portal Responses in OE (Incoming) option will allow you to review the data entered on the Web Portal by the client before it is filed in Order Entry.

**Client ID(s):** Enter Client ID(s), /L to select from a list of Client ID(s), or an \* for all Clients. Multiples can be selected.

**Payer ID(s):** Enter a Payer ID(s), /L to select from a list of Payer ID(s), or an \* for all Payers. Multiples can be selected.

**Aged Category:** Enter an Aged Category, /L to select from a list of Aged Categories, or \* for all Categories.

**Edit Reason(s):** Enter an Edit Reason(s), /L to select from a list of Edit Reason(s), or an \* for all Edit Reasons. Multiples can be selected.

**Ordering Location(s):** Enter an Ordering Location(s), /L to select from a list of Ordering Locations(s), or an \* for all Ordering Locations. Multiples can be selected.

**Sort By:** Enter an (A) for Accession, (C) for Client, and (L) for Ordering Location. Enter /L to select from a list.

Select **[Process]** to create the Work List, **[Edit]** to make changes to the selection criteria, or **[Exit]** to exit without creating the Work List.

## Release Edits to Portal (Outgoing)

If you selected the Portal Edit Type of **E** to **Release Edits to Portal**, the list of accessions with edits pending release to the Client Portal will be displayed on your screen. If needed, use your up and down arrow keys to highlight a specific accession. Press **[Enter]** on your keyboard to select an accession. Access the end of screen buttons by entering a **"/** and, then, pressing **[Enter]**. If you select the **[Print]** option, a screen will display for you to enter the Output Device. You may choose from a list of defined printers or to print to a file. Select **[Edit]** to return to the list of accessions. Select **[Exit]** to return to the Portal Edits Work List selection screen.

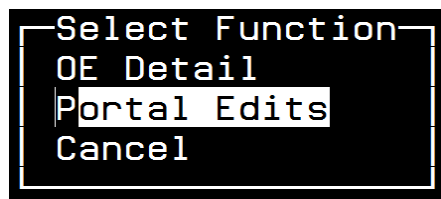

The Portal Billing Order Entry screen is displayed so you can review the accession and access the Portal Edits. The selected accession is displayed with the original Order Entry details. The Portal Edits Work List is only for review; changes cannot be made to the accession in this screen.

Use the end of screen **[Portal Edits]** button to view a list of edits to be sent to the Client Portal for this accession. Or, you may use the **Control + Z** command while the cursor is on a Test Ordered line to access the additional function options. You will be prompted to select a function. Choose Portal Edits to view details.

The Portal Edits pending release to the portal are displayed for review. Review the edits and Order Entry data as needed.

When you have reviewed the information for the accession, use the Portal Edits button at the end of the screen to access the Portal Edits Release screen to release the accession to the portal.

### *Portal Edits Work List – Release Edits (Outgoing)*

The Portal Edits Release screen displays five columns with distinct purposes.

- ✓ **Review Outgoing Edit?:** To let you know if the edit is defined for review prior to release to the client portal.
- ✓ **Review Incoming Edit?:** To let you know if the edit is defined for review and accept the portal responses prior to filing in SurroundLab AR.
- ✓ **Release Edit?:** Enter YES if you want to release this edit to the portal or NO.
- ✓ **Client Submitted Edit?:** To communicate that a Client Portal user has submitted data for a specific edit. It is possible for some edits to be released and resolved using this option.

## Edits

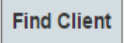
### Hovering

## Select the Role for the New User ID

Both Master and Super Users can create Sub Users. However, a Master User can only create Sub Users for their assigned Clients. Super Users can create Sub Users in any existing client set. **The Super User Role should be assigned ONLY to laboratory employees to avoid providing access to Protected Health Information (PHI) between your Referring Providers.**

### Role for New User:

- Master User - Can view and create Sub Users in existing client set.
- Super User - Can view and create Sub Users for any client.

If you are providing external access to the Client offices you serve, you should provide the Master User Role and select one or more Client IDs associated with that Client group. The Master User can then provide Sub User IDs to representatives inside the provider's office or offices to access the portal.

### ***Practical Example of Master User and Sub Users:***

Physician Associates is a group of providers who refer to your laboratory. Their Office Manager's name is Lauryn Ocasio. Lauryn has three office personnel who will need access to the Client Portal. Ms. Ocasio will be the Master User for this provider's office and she will create a Sub User for each of her personnel.

Consider that Physician Associates has three locations and each location manages staff separately. You could provide a Master User to each Office Manager who will create and manage his/her own staff logins as Sub Users for convenience.

If each location has a separate Client ID in your SurroundLab AR billing system, you can go one step further and assign only the Client ID associated with each location to the Master User. Then, the Master User will only be able to create Sub Users with access to the same Client ID.

## Creating a Sub User

When a Master User selects the Create New User button, the Role for New User is limited to Sub User. The Client ID list is limited to the Clients for which the Master User has been provided access. The Pages and Missing Info Edits options are offered.

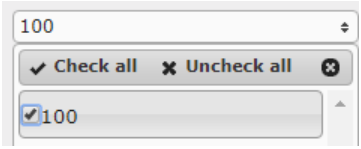

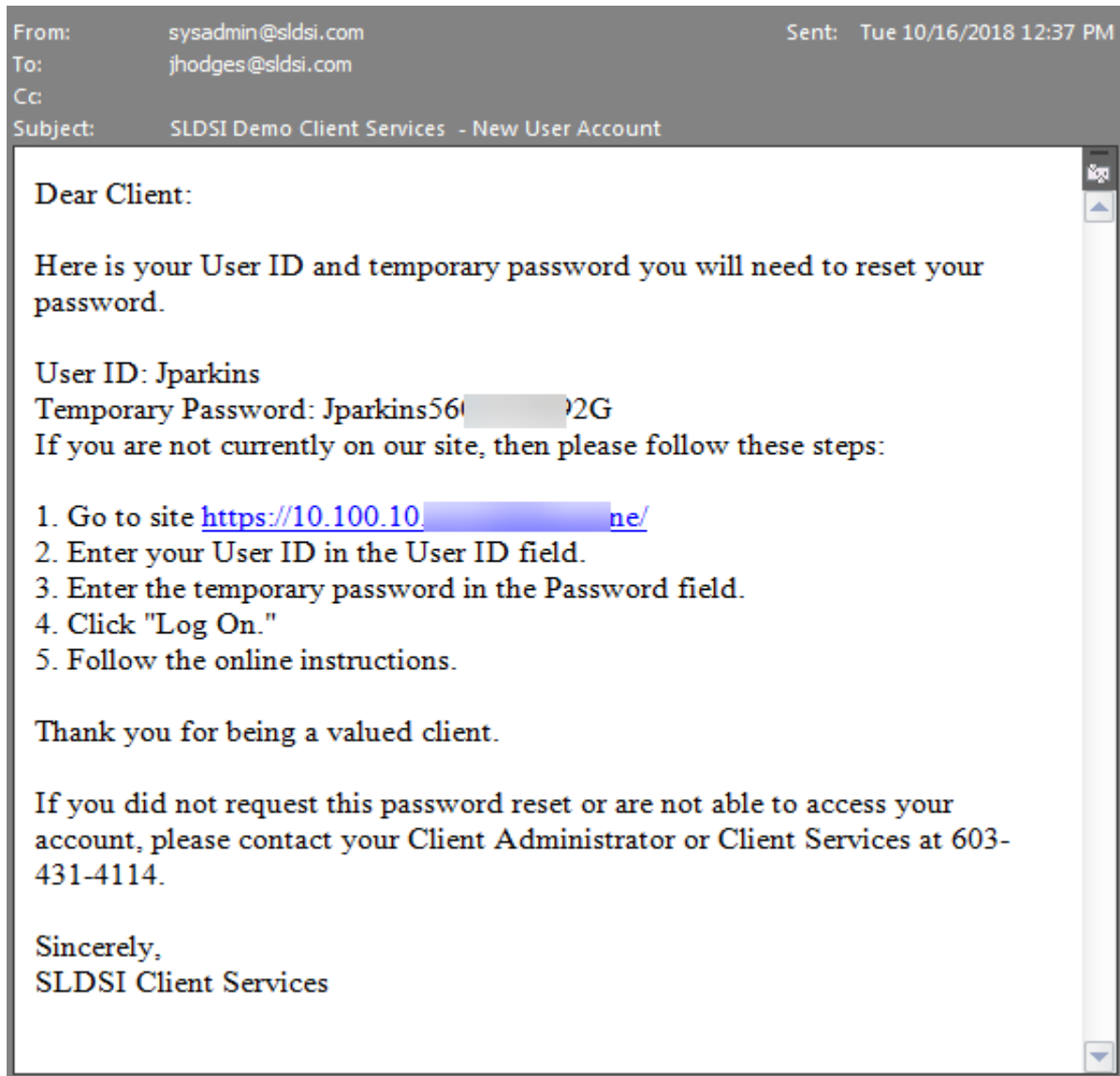

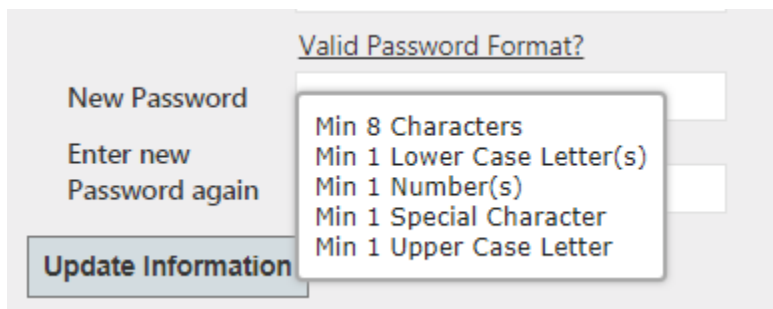
